FALL CLEANUP

The City's Fall Cleanup is scheduled for Saturday, October 19, 2019 and held in coordination with the City's refuse hauler, LJP. The cleanup is open to Eagle Lake residents only. Curbside pickup is only offered during the spring cleanup. All items to be disposed of must be brought to Lake Eagle Park (the area by the hockey rink) on October 19th between the hours of 8:00 a.m.-noon. LJP does not pick up appliances during the fall cleanup. No hazardous waste, appliance, or electronic disposal will be available.

Acceptable Items Include:

- General household garbage that is too large for your refuse cart
- Furniture (including bed, couch, recliner, etc.)
- Pedal bikes
- Grills without propane tanks

FALL LEAF COLLECTION

The Public Works Department will begin leaf collection the week of October 7th and continue until leaves are gone or snow arrives. Leaves should be raked to the boulevard.

CURRENT CONSTRUCTION PROJECTS

2019 Linda Drive Drainage Improvements Project

Contractor: Bromeling Excavating, Inc.

Construction Cost: \$94,552

Funding: Storm Water Drainage and Sewer Funds

Scheduled Start Date: September 30, 2019

Final Completion Date: November 15, 2019

Brief Summary: Redirect sump pump discharge flow underground by constructing subsurface drainpipe and making connections to the existing sump pump hoses that currently drain into the street and cause deterioration of the street.

2019/2020 Watermain Looping and Utility Improvements Project

Contractor: GM Contracting, Inc.

Construction Cost: \$618,203

Funding: Sewer and Water Funds

Scheduled Start Date: October 2, 2019

Final Completion Date: November 30, 2020

Brief Summary: The purpose of the project is to provide watermain looping and redundancy.

2020 BUDGET PROCESS

The preliminary City of Eagle Lake budget and property tax levy for 2020 was set at the September 16th Special City Council meeting. A Truth-in-Taxation public hearing has been scheduled for 6:00 p.m. on Monday, December 2nd in the Council Chambers at Eagle Lake City Hall. If necessary, a continuation hearing will take place at 6:00 p.m. on Monday, December 9th at the same location. A copy of the budget is available upon request at City Hall.

What does this mean for me?

Below is an illustration of the estimated City tax impact on a residential home valued at \$250,000.

Residential Taxable Market Value of \$250,000	2019 City Tax Rate of 33.40%	Estimated <u>City</u> Tax: \$835.00
Residential Taxable Market Value of \$250,000	2020 Proposed City Tax Rate of 34.68%	Estimated <u>City</u> Tax: \$867.03

The local property tax rate is a function of the levy and total tax base. Taxable tax capacity is used to determine the local tax rate. $[\text{city levy}] / [\text{taxable tax capacity}] = [\text{city tax rate}]$ Your share of the City levy is based on the taxable value of your property relative to the full value of all other property in the City's taxing district.

What is a Truth-in-Taxation notice?

Truth-in-Taxation notices are sent to all property owners each November, before local governments like Eagle Lake finalize their budgets for the coming year. The purpose of the notice is to help you understand how property taxes are determined and how you can get involved with local budgeting and taxation. The notice also tells you when local officials will hold public meetings to discuss and finalize their budgets. These meetings are an opportunity to voice your opinion about the proposed spending. You cannot appeal your property's market value, classification, or proposed taxes at these meetings.

How does my property value affect taxes?

The assessor determines the estimated market value (EMV) and classification of your property on January 2 each year. The EMV does not directly affect your property tax bill. Instead, the taxable market value is used to calculate how much of the levy you will pay.

What is a Property Tax Statement?

Property tax statements are mailed to all property owners by March 31 of each year. The statement tells you how much property tax you owe for the year. It provides an itemized list of all your local property taxes (city, county, school district, etc.). It will also include any special assessments on your property. Your property's value and classification from the previous year are used to calculate the tax amount.

IN PROGRESS...

A grant application was recently submitted in hopes of obtaining funding to be able to contract with Region Nine Development Commission to conduct a new strategic plan. The City's strategic plan was last updated in 2005.

A grant application was recently submitted to obtain funding to create a Music in the Park program in Eagle Lake, beginning in the summer of 2020.

In partnership with MVAC, a 2020 Small Cities Development Program (SCDP) grant pre-application will be submitted in November for grant funds that qualifying homeowners could use to fix up their homes.

Based on survey results received from residents located in the Eagle Heights Subdivision, the Park Board is currently researching playground equipment options and pricing.
