Re: Engine Failure and Repair Options – 2014 International Plow Truck

This memo provides information regarding the recent unexpected engine failure of the City's 2014 International plow truck, associated repair costs, and a recommended course of action.

While en route to pick up sand on January 15, the plow truck experienced an engine failure and seized, preventing the engine from turning over. Affordable Towing transported the vehicle to North Central International for inspection.

The most recent inspection and maintenance invoices for the truck are included with this memo. Based on conversations with Public Works Director Andrew Hartman and North Central International LLC, the exact repair cost is not yet finalized. However, the minimum estimated cost to replace the engine is \$42,793.56. North Central International LLC is currently completing a component failure analysis and is expected to provide final pricing before or at the council meeting.

Included are estimates for both engine replacement and engine rebuild options. Both Public Works Director Hartman and the North Center International rep recommend replacement over rebuilding due to the longer warranty.

This item is being brought to the City Council because the repair was unplanned and the cost exceeds the authorization threshold for staff approval. The cost will be paid out of street capital outlay (101-42100-510).

Once approved, the engine replacement is expected to commence within 2–3 days, depending on order timing.

Public Works Director Hartman will be available to answer questions at the meeting.

Discussion should ensue. A motion is needed to either approve an engine replacement or rebuilding of the existing engine.
