Did you know that most American children can only recognize a few tree species? A U.S. Department of the Interior study found that the **average American child can identify 1000 corporate logos but can't ID 10 plants and animals native to his or her hometown.** Come out and add a few more trees to your positive ID list!

This event is intended for children and adults. Participants will tie color-coded ribbons to trees to indicate species in the park and take green ribbons to mark Ash trees in their own neighborhoods. When the Emerald Ash Borer reaches Eagle Lake all the ash trees will be at risk. That's why it's so important to refrain from moving firewood this winter. Please get your firewood as close to home as possible! Learning how to identify trees is the first step in helping to prevent Emerald Ash Borer spread. It's also a great way to appreciate nature and a good skill for those interested in foraging!

DON'T FORGET TO LEAVE THE LEAVES

Mulching leaves into your lawn can be an excellent way to take care of fallen leaves AND get free, natural fertilizer.

Most deciduous tree leaves contain about

2% NITROGEN

which is a very important nutrient for plants

By mowing over the leaf litter scattered about in the lawn, you are essentially getting a free nitrogen fertilizer application.

TO SUCCESSFULLY MULCH LEAVES

INTO YOUR LAWN

- It is important to mow frequently so leaf litter doesn't build up.
- The goal is to chop the leaves into small pieces, so they compost in place.
- Mulching only works if you mow frequently, so don't wait too long.
- If your lawn gets covered with many leaves, it will be difficult to fully mulch them in with a mower.



Thick layers of leaves left on the lawn throughout fall and winter can be problematic, shading the turf and increasing the likelihood of snow mold. The best way to know if you have too many leaves on your lawn is to take a few passes with your mower and observe how well the mulching is working.

Leaves are a great source of nutrients for turf, but they can also be great mulch for your gardens. If you have leaves that fall into garden beds under a tree or in your landscaping, leave them be. They help insulate plants from harsh winter conditions, conserve moisture, and control weed growth. Those leaves also provide habitat for pollinators.

Approval was obtained at the September 13th meeting to purchase a new leaf vac unit. In addition to the new leaf vac unit, the Public Works Department will continue utilizing the old leaf vac unit around town as needed.

Residents are asked to please rake leaves to the boulevard and NOT INTO THE STREET OR GUTTER to help keep leaves out of the catch basins. Residents are encouraged to mulch leaves when possible.

DOG LICENSES

Per Eagle Lake code, all dogs within city limits must be licensed. Please be sure that your dog wears its metal tag that is issued with the dog license. This helps the police identify where a dog lives so that it can be returned home if lost versus being impounded.



Please call or stop by City Hall to obtain a dog license application if your dog is not currently licensed.

Replacement tags are available at **NO CHARGE** if a tag is lost or damaged.

BUILDING AND ZONING PERMITS

Building permits are required for almost all construction projects including but not limited to new homes, garages, additions, decks, sheds over 200 square feet, windows, roofing, siding, etc. A building permit is also required for any building being moved onto a lot or any building being demolished. A zoning permit is required for sheds 200 square feet or less, patios, and fences.

INTERSECTION IMPROVEMENTS

HWY 14/COUNTY ROAD 56 IN EAGLE LAKE

CONSTRUCTION PLANNED FOR 2022

Following an analysis of intersection alternatives, the Minnesota Department of Transportation (MnDOT), Blue Earth County, and the City of Eagle Lake are moving forward with a Restricted Crossing U-Turn (also referred to as a J-Turn) at the intersection of Hwy 14 and Blue Earth County Road 56 in Eagle Lake. **Construction is planned for 2022**.

Additionally, MnDOT recently installed pavement markings on CR 56 to encourage motorists to stop closer to Hwy 14, which improves visibility for CR 56 traffic as they either cross or turn onto Hwy 14. MnDOT worked closely with the project partners, as well as collected input from the community prior to arriving at the selected alternative of an RCUT. The public was invited to share feedback on the proposed concepts through a virtual presentation and online survey. WHAT DOES THIS MEAN FOR ME?

Below is an illustration of the estimated City tax impact on a residential home valued at \$250,000.

The local property tax rate is a function of the levy and total tax base. Taxable tax capacity is used to determine the local tax rate.

[city levy] / [taxable tax capacity] = [city tax rate]

Your share of the City levy is based on the taxable value of your property relative to the full value of all other property in the City's taxing district.

WHAT IS A TRUTH-IN-TAXATION NOTICE?

Truth-in-Taxation notices are sent to all property owners each November, before local governments like Eagle Lake finalize their budgets for the coming year. The purpose of the notice is to help you understand how property taxes are determined and how you can get involved with local budgeting and taxation. The notice also tells you when local officials will hold public meetings to discuss and finalize their budgets. These meetings are an opportunity to voice your opinion about the proposed spending. You cannot appeal your property's market value, classification, or proposed taxes at these meetings.

HOW DOES MY PROPERTY VALUE AFFECT TAXES?

The assessor determines the estimated market value (EMV) and classification of your property on January 2 each year. The EMV does not directly affect your property tax bill. Instead, the taxable market value is used to calculate how much of the levy you will pay.

WHAT IS A PROPERTY TAX STATEMENT?

Property tax statements are mailed to all property owners by March 31 of each year. The statement tells you how much property tax you owe for the year. It provides an itemized list of all your local property taxes (city, county, school district, etc.). It will also include any special assessments on your property. Your property's value and classification from the previous year are used to calculate the tax amount.
